CAMPING - FREQUENTLY ASKED QUESTION'S (FAQ'S)

Q: What is the cost? Is this per night, per site, per person?

A: \$65 per person (Kids 12 and under free)

Q: Does camping include entry to the event?

A: No, you must buy an event ticket as well through Ticketek on 132 849 or www.Ticketek.com.au.
We recommend purchasing a ticket early through Ticketek to avoid any delays on your arrival

Q: Are powered sites available?

A: No.

Q: Is there an area for campervans/mobile homes/caravans?

A: No, not specifically.

Q: Can I sleep in my car?

A: No.

Q: Can I park my car next to my campsite?

A: No. There will be a dedicated car park next to the Campground.

Q: Can I reserve my preferred site or are sites issued on a first in basis?

A: No, sites are allocated on a first in first served basis.

Q: Can I view the circuit/race from my campsite?

A: No.

Q: What hot water/shower/toilet facilities are on site?

A: There are shower & toilet facilities provided in the campgrounds.

Q: Are there any disabled facilities?

A: Yes, a disability accessible toilet and shower are provided..

Q: Are there any facilities for babies?

A: No.

Q: Are there any food/catering facilities within the campgrounds?

A: No, campers are encouraged to come self sufficient.

Q: Is there a general store?

A: No.

Q: Can I bring my own alcohol?

A: Yes, but only into the Campgrounds. Security will be monitoring drunk and disorderly behavior and reserve the right to evict unruly patrons.

Q: Is ice available on site?

A: No.

Q: What is a prohibited item?

A: Prohibited items are listed on the Conditions of Entry at www.V8supercars.com.au

Q: Can I have a campfire?

A: Only small contained campfires are allowed. Security reserve the right cease campfires which pose a safety threat.

Q: Can I bring my own firewood?

A: Yes.

Q: Are there any restrictions on the type or size of tent?

A: Properly secured camping tents are acceptable. Marquee structures are not and no structure can be over 100m2.

Q: When does the Campground open & close?

A: Campgrounds open at 7.30am Friday 16 September..
Campgrounds must be clear by 9.00am Monday 19 September.

Q: How do I access the Campground?

A: Specific Campground access is through Gate 2 off Back Beach Road (150m past Gate 1).

Q: How do I buy a Camping ticket?

A: Directly from the Phillip Island Grand Prix Circuit on 1300 728 007

Q: Do I need to pre-book or can camping be purchased at the event?

A: You can pre-purchase your camping ticket or purchase it at the event.

Q: Can I come & go from the Campgrounds at night?

A: Yes however Circuit access is strictly prohibited outside of gate opening and closing times.

Q: Where do I redeem my camping voucher for a wristband?

A: From the campground office at Gate 2.

Q: What if I arrive when credentials office is closed?

A: You will need to speak to the Security Guard at Gate 1 (or Gate 7 After Hours)

Q: Will there be entertainment provided in the Campgrounds?

A: No however there will be an exclusive invitation to all camping patrons to attend Saturday Nights Pit Lane Party. The Pit Lane Party includes:

- Pit Lane Walk Saturday (at approx 515pm), followed by,
- Driver Autograph Session (V8 Supercars and Support Categories)
- Driver Q&A
- Fee Nibbles and Cash Bar

Q: Will there be a quiet or family area?

A: There will not be a specific area as such however Security will be monitoring patron behavior at all times to ensure that no unruly or antisocial behavior takes place in the Campgrounds.
